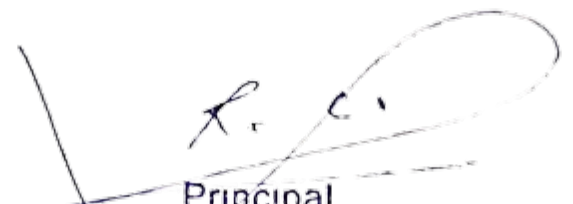

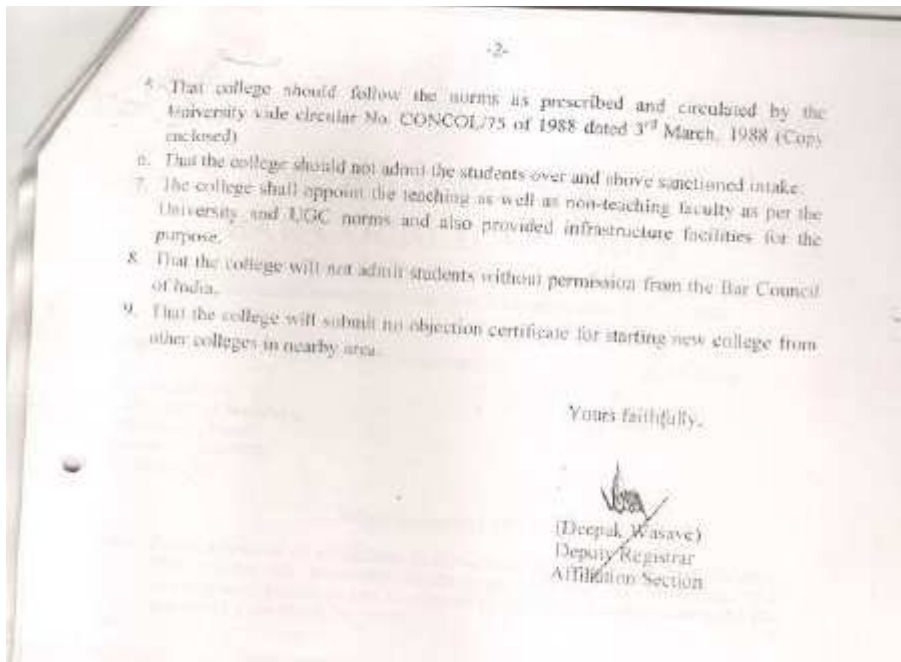
In this connection, I am directed to inform you that, considering the permission

with intake of 60 students each from the academic year 2018-19.

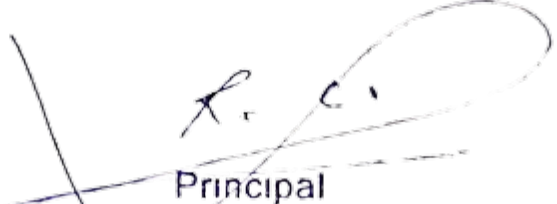
Further, the college has to fulfill the conditions mentioned in the above referred

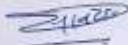

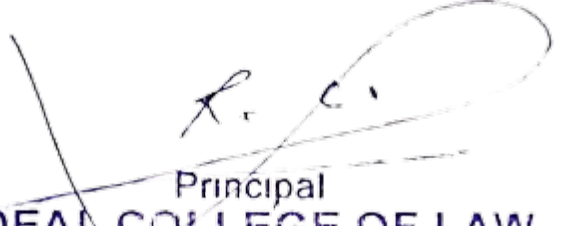

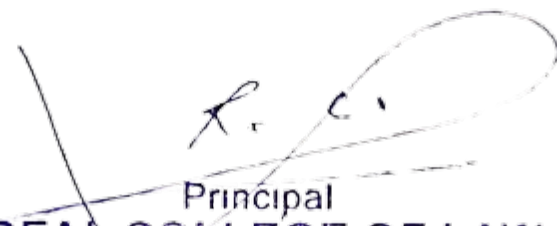
